2. All times and dates specified in these Terms and Conditions are times and dates in Sydney, which may be Australian Eastern Standard Time ("AEST") or Australian Eastern Daylight Time ("AEDT") depending on the date.
3. The competition is open to residents of Australia:
 - a. Entrants must be 16 years of age or over to be eligible.
 - b. Entrants must be residents of Australia.
 - c. Entrants must not be a Luna Park Sydney employee or an immediate family member of a Luna Park Sydney employee (or an employee of any entity or agency associated with the competition).
